Reference is invited to the Notification dated 13th July 2018 issued by JKB FINANCIAL SERVICES LIMITED (a wholly owned subsidiary company of J & K Bank Limited) inviting applications for various contractual positions in JKB FINANCIAL SERVICES LIMITED.

Shortlisting for the positions of Relationship Managers, Compliance Executive, Finance & Accounts Executive, Risk Management Clearing & Settlement Executives, Executive Assistant to the Managing Director, Human Resource Executives, IT Executive, Relationship Executives, Processors and Dealers shall be done through online written test of all the applicants found eligible as per the basic eligibility criteria prescribed in the original notification dated 13.07.2018. The test shall be conducted through an independent agency namely "IBPS-Institute of Banking personnel Selection". The test shall be common for a group of positions which are categorised as Level-I for the positions of Relationship Managers, Compliance Executive, Finance & Accounts Executive, Risk Management Clearing & Settlement Executives, Executive Assistant to the Managing Director and as Level-II for the positions of Human Resource Executives, IT Executive, Relationship Executives, Processors and Dealers. Accordingly Candidates having applied for multiple positions falling in a single level i.e. either Level I or Level II shall have to appear in common online test once only while as those candidates who have applied for multiple positions in both the levels i.e. Level I and Level II shall have to appear in two separate examinations. Merit lists for each position shall be derived separately on the basis of marks obtained in the online written exam. The shortlisting of candidates for interview/s shall be on the basis of 1X3 (for each position the number of shortlisted candidates shall be three times the notified vacancies). Weightage of merit in written exam to performance in interview shall be 80:20. 50% weightage (i.e. 10 out of 20 points) shall be given to related work experience in the interview.

Structure and syllabus for online written test is available on the website of JKB Financial Services Limited (www.jkbfsl.com). The test shall be conducted on 02.01.2019 (Wednesday) within the state of J&K. No TA/Da shall be paid by the company.

The list of all eligible candidates against various positions has also been uploaded on the website of the company. Applicants who were not found eligible as per the eligibility criteria have, accordingly, been notified through their e-mails. Since no applicant has been found eligible for the position of 'Manager Finance & Accounts', hence the said positions shall not be available for filling through this process.

All other terms and conditions mentioned in the Notification dated 13th July 2018 shall remain same.
